- (2) Further as required under regulation 6 of Appendix-B of "The Master of Pharmacy (M.Pharm) Course Regulations, 2014", the Examining Authority and institution shall communicate to the PCI, not less than six weeks in advance the dates fixed for examinations, the time-table for such examinations, so as to enable the Council to arrange for inspection to attend at such examinations."

D. Approval of various pharmacy courses for the academic session 2018-2019 -

- It was noted that there are cases where inspections of pharmacy institutions are still to be carried out for the purpose of considering approval or extension of approval or increase in the intake capacity. The delay is due to various procedural constraints.
- (2) In view of above, it was decided that all out efforts be made to complete the inspection as soon as possible and admissions be considered for the academic session 2018-2019 based on SIF keeping in view of the various court orders in this regard.
